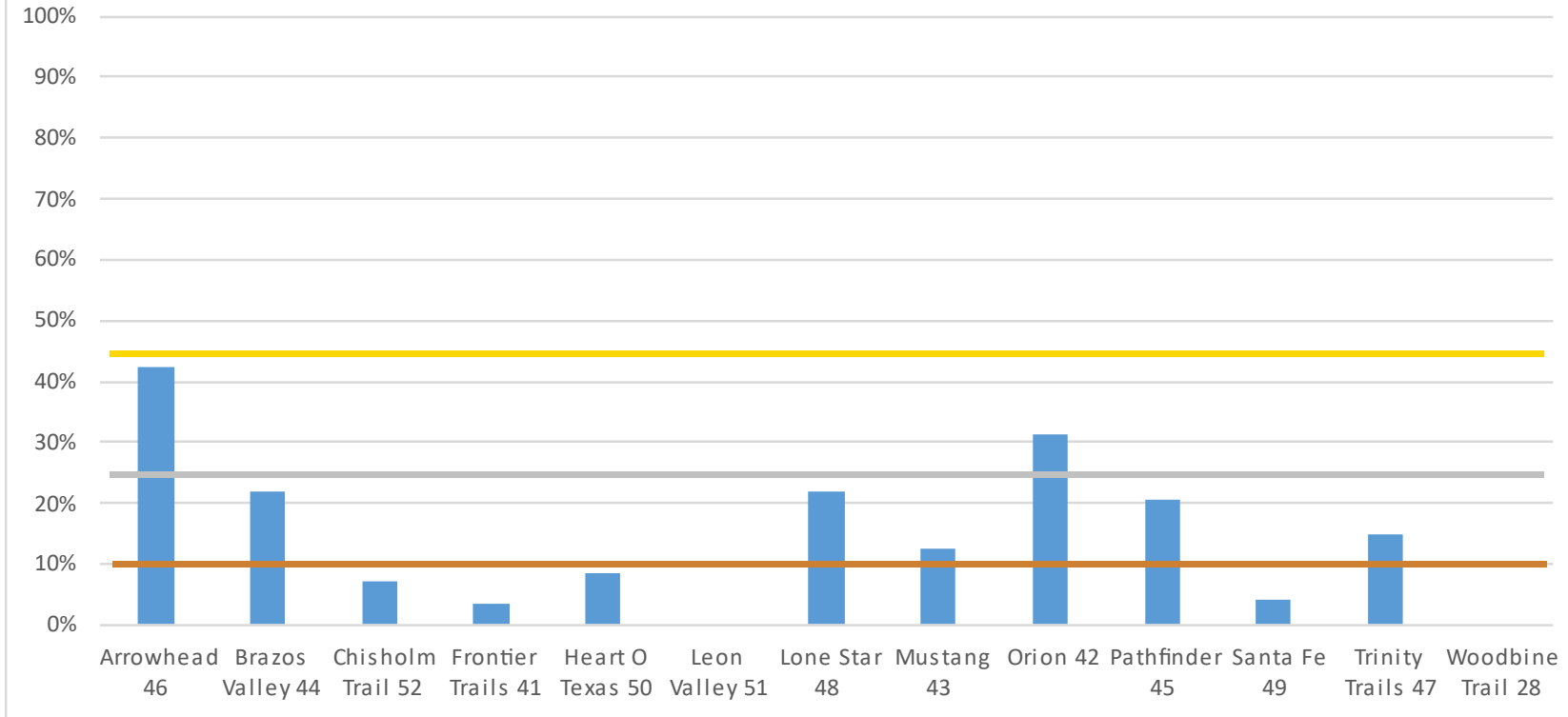


Items of interest...

Percentage of Units on Track for JTE Contact Gold Units \geq 6 contacts including 1 Detailed Assessment



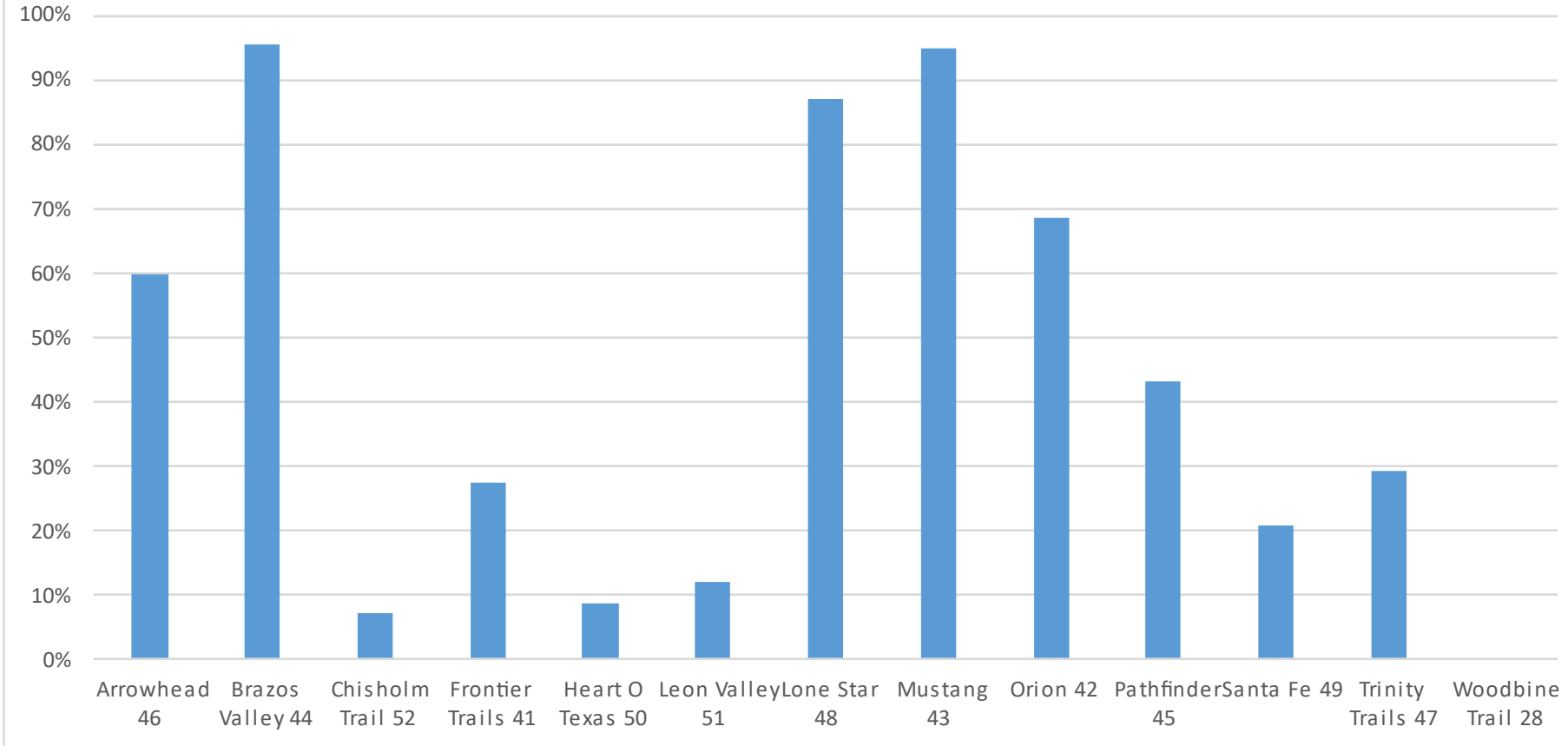

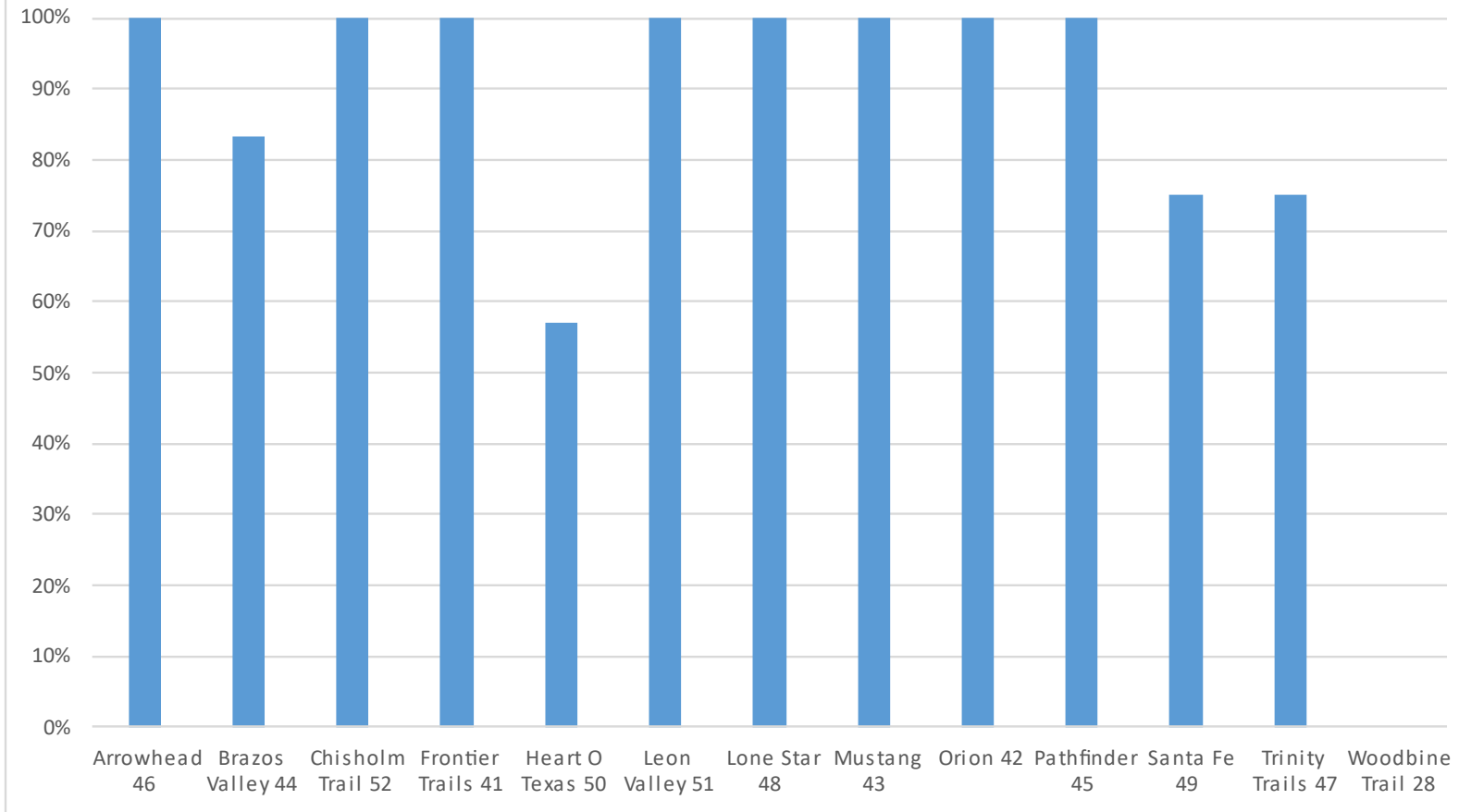


Percent Units with Detailed Assessment



Percentage of New Units Contacted this Year

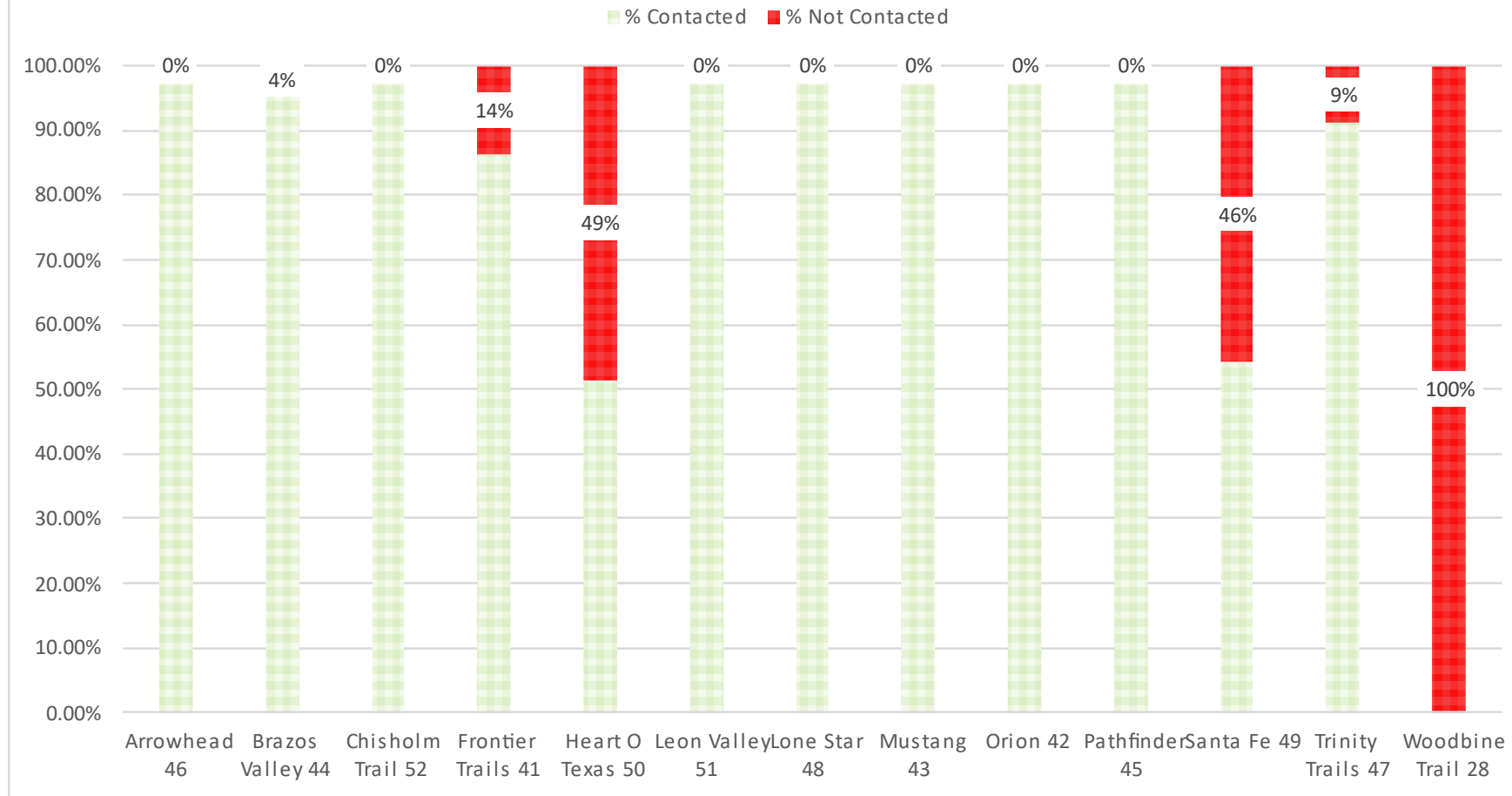

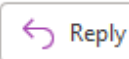

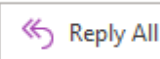

This is the email I just sent out as Chair of the Diocese of Fort Worth Catholic Committee on Scouting

Good Evening Dear Catholic Scouters,

We understand that many of you have received word from your parishes that the Diocese will not allow the parish to recharter until after the bankruptcy is complete.

In speaking with Scot Fuller the Council's Director of Field Services, we recommend that you transition your units into Council registered units. If the Diocese does move forward with chartering after the bankruptcy we can move them back to being Diocese/Parish chartered units.

Your participation in Youth Protection Training helps to ensure that we protect our children to the best of our ability and that we obey Our Lord's command: "Let the children come to me, and do not prevent them; for the kingdom of heaven belongs to such as these" (Mt 19:13).

I pray that you and your families have a wonderful Christmas as we celebrate the birth of our Savior.

Youth Protection Training

- Youth Protection Training is required for each adult on the unit charter, and all adults registered in Scouting in the Longhorn Council.
- **All adults must have record of current YPT certification through the end of 2023.**
- Every new Adult Application must include a Youth Protection Training certificate.
- Please make sure all adults have valid YPT certification. You will not be able to complete your charter renewal if any registered adult has expired YPT certification during 2023.
